Dear Friends of Harmony House,

Harmony House has some exciting news to share with you. We are getting ready in April to celebrate our 10th anniversary as a children's advocacy center. During this time we have grown to become a community resource for the assessment, intervention, and prevention of child abuse for Ohio and Marshall Counties, West Virginia and Belmont County, Ohio.

Last year at Harmony House a record high of 933 children and non-offending family members received help; 359 specialized child forensic interviews were completed; 87 referrals were coordinated for medical evaluations; 169 children were referred to trauma-focused therapy; and over 7,500 people received child abuse education. Please keep in mind that these are all local children and families.

Harmony House invites you to attend "Ten Years of Hope" – a celebration of Harmony House's 10th

anniversary and the resiliency of abused children. We are proud to announce the luncheon's keynote speaker will be Katie Beers. Katie has been in the national media lately talking about the 20th anniversary of her abduction by a family friend a few days before her tenth birthday in 1992. She was held captive in a Long Island underground cell for 17 days. During this time she was sexually abused. When



Katie was rescued she was able to not only detail this event but

also years of neglect, physical abuse, and prior sexual abuse. Katie has co-authored her story of survival, memory, and recovery in Buried Memories: Katie Beers Story. Her book is now on the NY Times best seller's list.

The luncheon's date is April 26th at Undo's in Elm Grove, WV from 11:30-1:00. The price of the event is \$20 per person or a table for eight for \$120. If you would

In addition, if possible, we are asking Harmony House supporters to contribute \$10 to the "Ten dollars for Ten Years of Service" campaign to raise funds to help with the continuation of Harmony House services. Community support is vital since Harmony House doesn't charge for its services. In ten years we have provided over 1,830 opportunities for a child to tell his or her story through the child forensic interview process. Over 45,000 participants have strengthened their knowledge regarding child abuse through our community education outreach services. Harmony House is asking you for \$1 per year for what has been accomplished by working together to give our children a voice so they can go from victim to survivor to thriver. Harmony House appreciates your support both financially and emotionally. Without you there would be no Harmony House. Thank you so much for caring about the children we so humbly serve.

Harmony House has now completed it's first full year at the Belmont County site.

We were very sad last year to lose a champion of children when Bethesda Chief of Police Tim Zdanski died. He was instrumental in the formation of our center in Belmont County with his continuous support and encouragement. His knowledge of internet crimes against children was vital to this area and he will be greatly missed.

What is the focus of a Children's Advocacy Center?

The primary focus of every Children's Advocacy Center is child sexual abuse. Harmony House also provides services to children who allege physical abuse, drug endangerment, witnessing of violence, and severe neglect. In addition to children, services are available for adults with special needs who allege some kind of victimization. Services are also available for non-offending family members.

The targeted service area is Ohio and Marshall Counties, West Virginia and Belmont County, Ohio. Harmony House will try to accommodate referrals for assistance outside of it's service area on an individual basis. For more information call 304-230-2205 or 740-695-0812

ONE WITH COURAGE

"One with Courage" is the West Virginia Child Advocacy Network's statewide initiative centered around the courage it takes to talk about child abuse. This month there have been commercials on TV encouraging us all to be advocates for children and to learn the signs of abuse, share the information and be the "One with Courage" to make a difference.

<u>SIGNS OF ABUSE</u> Below are indicators of child abuse that can include but are not limited to these signs. Some signs that a child is experiencing violence or abuse are more obvious than others. Trust your instincts.

Suspected abuse is enough of a reason to contact the authorities.

You do not need proof.

Unexplained injuries Changes in sleeping Changes in behavior Changes in eating

Returning to earlier behavior Lack of personal care or hygiene

Fear of going home Risk taking behaviors

Inappropriate sexual behaviors

Changes in school performance and attendance

If a child outcries:

Remain Calm Panic or overreact

Believe the child Press the child to talk

Allow the child to talk Promise anything you can't control

Show interest and concern Confront the offender

Reassure and support the child Blame or minimize child's feelings

Take action. It could save a child's life Overwhelm the child with questions
