


# The Search for new direction...

Within a very short time, Harmony House secured community support, grant funding, national accreditation, well sponsored fundraiser events and the current home at OVMC's South Tower. The no nonsense, no cost, all child focused approach on services led to a second location in St. Clairsville (Belmont County), Ohio in 2011. Until December of 2016, the founder and Executive Director of Harmony House, Leslie Vassilaros kept safe watch over the Upper Ohio Valley, living her life for every child.

As of December 1, 2016 through spring of 2019, Debra Hawkins became the next Executive Director. It was her desire to utilize new technology, a different set of community contacts, and different skills and professional experience to take Harmony House in a positive direction. During this time period, the Leslie Vassilaros Hope's Hero award was conceived, the Beer, Bourbon

# 2019, so far

This year, Harmony House, between the two centers, has completed 207 forensic interviews. 93 were done in Ohio and the remaining 114 were done in West Virginia.

55.5% of the cases disclosed some form of abuse or neglect. (55% OH & 56% WV) Harmony House has served 500 kids, 21 adults and 243 family members this year.

764 Served in 2019 so far. 520 Children. 1,101 Served in 2018 Total. 718 Children.
